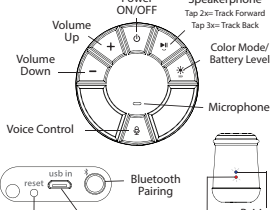

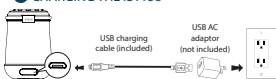

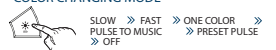

VOICE CONTROL

SIRI/GOOGLE ASSISTANT

Press and hold **O** to access the voice assistant from your Bluetooth device.



Enjoy Alexa voice control from the iBT158 when connected to an iOS or Android device.

USING ALEXA WITH THE IBT158

- Download the iHome Alexa OTA App from the Apple App Store or from Google Play.
- Follow instructions in the iHome AMA OTA app to connect the iBT158 to the Amazon Alexa app.
- Once your device is linked, tap **O** to activate Alexa!

LED STATUS INDICATOR (TOP OF UNIT)

While Charging:

- = battery level < 95%
- = battery level > 95%

No Charger Connected:

- = battery level < 15%
- = battery level 15-100%

Bluetooth Pairing:

- = pairing
- = connected to Bluetooth

BATTERY LEVEL REVIEW



Press and hold the Color Mode Button to enter Battery Review Mode. A voice prompt will confirm battery level status.

Note: after 60 minutes of no activity or audio, the unit will automatically power off to conserve the battery.

USING SPEAKERPHONE



The speaker must be on and connected with a paired Bluetooth device to receive calls. Press the Speakerphone Button to answer incoming call. Press + hold to ignore/end call.

WATERPROOF COVER



Make sure the waterproof cover on the back of the unit is completely flush with the unit by pressing along the entire edge of the cover until it is completely and securely in place.

BUTTON LOCK FEATURE

When Power is ON, press and hold the Power Button for 5 seconds to lock the Buttons. (Recommended when storing/traveling to save battery.)

To deactivate lock mode, press and hold the Power Button for 5 seconds.

Internal Rechargeable Lithium-Ion Battery

This device uses an internal non-replaceable rechargeable lithium-ion battery that should last the lifetime of the device. If you suspect your battery may be dead, try charging it for an extended period of time and try resetting the unit. If this fails, contact Customer Service at 1-800-288-2792.

WARNING/DISPOSAL OF UNIT

Do NOT attempt to change the battery. Doing so will void the warranty and could cause injury and damage to your device. To dispose of the unit, follow the instructions below:
